THIS IS A FAMILY ORIENTED FAIR, DISPLAY OR DISTRIBUTION OF ANY OBJECTIONABLE MATERIALS IS PROHIBITED. ANY OFFENDING VENDOR WILL BE REQUIRED TO REMOVE ANY OBJECTIONABLE MATERIALS OR DISPLAY IF THERE ARE ANY COMPLAINTS.

### **DISTRIBUTION OF MATERIALS OR SOLICITATION OUTSIDE OF VENDOR BOOTH IS PROHIBITED.**

SIGNS, POSTERS, BANNERS, ECT. **WILL NOT** BE TAPED OR GLUED TO ANY WALL. THEY MUST BE FREESTANDING OR THEY MAY BE HUNG FROM THE CHANNEL AT THE TOP OF THE WALL WITH "S" HOOKS.

BOOTHS MAY BE SET UP SUNDAY AFTERNOON OR MONDAY PRIOR TO FAIR OPENING.

ALL BOOTHS MUST BE TAKEN DOWN BY MONDAY AFTERNOON FOLLOWING THE CONCLUSION OF THE ONSLOW COUNTY FAIR.

VENDORS **MAY NOT** TAKE DOWN BOOTHS PRIOR TO CLOSING ON THE LAST DAY OF THE FAIR WITHOUT PERMISSION FROM THE FAIR MANAGER.

ONSLOW COUNTY FAIR WILL NOT BE HELD RESPONSIBLE FOR ANY LOST OR STOLEN ITEMS. DO NOT LEAVE YOUR BOOTH UNATTENDED DURING OPERATING HOURS, IF YOU HAVE VALUABLE ITEMS TAKE THEM WITH YOU.

ONLY VENDORS ARE ALLOWED ADMITTANCE WITHOUT CHARGE. FAMILY MEMBERS AND CHILDREN ACCOMPANYING THEM MUST PAY AT THE GATE.
